## **SECTION 3: PROCEDURES**

*3.1 Standard Operating Procedure on how to respond to a suspected case of COVID-19 including isolating guests/staff.*

*Identify Suspected Case*

*Isolate Suspected Case*

*Call HPA – Health Protection Agency (1676)*

*3.2 Boat cleaning and disinfecting procedures*

- Boat is washed with soap and water.
- Boat is disinfected with diluted bleach solution 1 m l bleach to 9 ml water (keep for 10 minutes)
- Boat is sanitized with Ozone machine
- Active monitoring to be continued on the vessel for 14 days to look for anyone with acute respiratory infections.

*3.3 Procedures of cleaning and disinfecting of diving and snorkeling equipment*

- No common rinsing tanks will be implemented to rinse any piece of equipment, while stern showers will be available for single use.
- Each guest will keep their own equipment in their individual basket, making sure no one else touches them except themselves.
- At the end of every safari the crew responsible for cleaning and disinfecting the equipment will provide to clean and disinfect masks, snorkels and regulators, and all mouthpieces will be protected and isolated in plastic, in order to avoid any contact with people or surrounding objects.

## **SECTION 4: IDENTIFICATION OF BOAT AREAS**

### **4.1 Location of hand washing facilities.**

- Hand washing facility is available in each room and main lounge area.

### **4.2 Identification of zones or spaces where masks are required.**

- Crew and Guests will be required to wear masks in all common areas of the boat

**4.3** In each common area, restaurant included, it is possible to keep social distance in case of multiple groups of guests traveling together.
